

| <p>01 Articles of Association
Execution of the Company's Articles of Association in the form of a notarial deed.</p> | <p>04 Entry in the National Court Register
The Management Board shall, within 6 months from the date of conclusion of the agreement, report the company's establishment to the registry court.</p> |

The conclusion of a contract of a limited liability company in the form of a notarial deed requires a visit to a notary office.</p> | <p>05 Entry in Central Register of Real Beneficiaries
Failure by a company to notify a beneficiary to the Register is punishable by up to PLN 1,000,000 (approx. EUR 222,222).</p> |
| <p>03 Proof of Paid Share Capital
The shareholders should contribute to the Company's share capital a minimum amount of EUR 1,250.</p> | <p>06 Setting up a Bank Account

ESSENTIAL ASSOCIATED ACTIVITIES

Signing and notarizing a power of attorney (POA)

A power of attorney (POA) is a legal document in which the principal (you) designates another person (called the agent or attorney-in-fact) to act on your behalf.

Legal business name verification procedure

If you are thinking of registering an EU mark, we will check collision with marks from all 28 EU countries. Then we will conduct assessment of similarity of goods and services.
